5. We have received a communication from Lloyds Bank regarding the Financial Services Compensation Scheme (FSCS). The letter confirms that the FSCS does not protect all funds held with Lloyds Bank in the event of the bank's insolvency. The maximum coverage limit provided by the FSCS is £85,000 per depositor.

Currently, the funds held with Lloyds Bank are as follows:

• Current Account: £63,612 *

• Fixed Term Deposit Account: £340,000

It is important to note that this information likely applies to ALL investment accounts holding funds for Saltash Town Council. Despite this, the risk remains extremely low as the investments are managed with reputable banking institutions.

* We hold around 5% of the annual operational expenditure in the current account for cash flow purposes (2024/25 £1.5m).

6. CIL (Community Infrastructure Levy) Neighbourhood Parish Payments

Saltash Town Council's CIL report for 2023/24 was submitted to Cornwall Council on 4 June 2024. See attached. This document can also be found on the STC website.

The Town Council EMF CIL Planning Budget availability is £13k with various deadline dates (shown in the table below) to use the funds.

The Town Council submitted an Expression of Interest (EOI) for the 4th round of Community Infrastructure Levy (CIL) funding for the Saltash Waterside Improvement Project, allocating £10,000 from the EMF CIL Planning Budget. Cornwall Council have since invited the Town Council to submit a Full Application for consideration.

The Services Committee meeting held on 11 April 2024 recommended to this evening's Policy and Finance Committee the allocation of £10,000 from the EMF CIL Planning Budget upon Cornwall Council awarding the grant to the Town Council. If awarded, this would leave a remaining balance of £3,000 in the EMF CIL Planning Budget.

Members are encouraged to consider how best to utilise the funding received and to avoid the need to return unspent funds to Cornwall Council.
