
# **Background:**

#### **Leisure Centre**

The Leisure Centre survey received 4,700 responses. We have been informed that additional officer time has been allocated to ensure that the responses are collated, and the results will be made publicly available. The information will be included in the report that will be debated by Cabinet in December.

## Walking/Cycling routes


For many years, there have been issues with road safety outside St Stephens School, as well as issues at the Broad Walk entrance of Saltash Community School. As Phase 2 of the Walking and Cycling Routes, Cornwall Council commissioned Aecom to develop schemes in these areas. The draft schemes are now at a stage where they can be shared with town councillors for their input before going out to public consultation. We are hoping that we can fix a meeting with town councillors on 17<sup>th</sup> or 18<sup>th</sup> November.

#### **Fore Street**

Bus and parking bays on Fore Street will be resurfaced in the week commencing 8<sup>th</sup> November, in order to remove the Covid 'humps' and repair the unsafe surfaces. The taxi rank will also be repaired. When this is taking place, the teams will relocate the taxi bay to the adjacent parking bay and sign accordingly.

I've been given assurances that the works will be undertaken as quickly as possible and that every effort will be made to ensure there is minimal disruption to pedestrians, traders and traffic.

#### **Climate Action Online Event**



The online event will feature a series of six themed conversations, focusing on the areas of Cornwall's highest carbon emissions. Following on from the event Cornwall Council will be engaging with groups and organisations to co-design a series of 'Cornwall Climate Commitments' to encourage everyone to take climate action and reduce Cornwall's carbon footprint.
