Summary of request: Questions relating to Saltash Library

Response:

1. It is normal for any new owner of a facility to conduct their own Asset Condition Survey. This will give the company, or in this case, Town Council, a projected cost for running the facility from date of occupation. I note that this is missing from the pack I was sent. Perhaps you would be good enough to forward it to me. I would hope that the Town Council has not relied on the County Council costings, which to say the very least are out of date by a number of years.

The Building Survey Report carried out on behalf of the Town Council is attached.

Separate financial data was provided to the Finance Officer by Cornwall Council up to July 2018 (I have attached this), any missing data CPI was added to bring the figures up to date. Actual Expenditure £97,792 Against Budgeted £102,612 for 2019/20 (First Year of Operation). The difference was due to staff shortages from Oct 19 – Mar 20.

2. There is no Forward Maintenance Register in the pack. This should have been included as it would set out the list of items requiring renewal over the next 5 to 10, or even 15 years. It will give the Town Council a reasonable idea of the true running costs of the facility in the short to medium term.

A copy of the Five Year Maintenance Plan is attached.

3. There was no green energy statement. This would set out the County Councils proposals to capture green energy and cut the facilities carbon footprint. It would normally include feasibility studies for the installation of solar panels, geothermal heat recovery and the use of energy efficient glazing. The study should conclude if it is possible to utilise any of these plans to reduce the carbon footprint and the likely energy savings.

The Town Council considers this a statement, not a question.

4. The reactive maintenance budget as supplied by the County Council, only appears to cater for mechanical and electrical services. There appears to be no budget for reactive building repairs, perhaps you could enlighten me.

A copy of the Library Budget is attached.

5. There is nothing in the budget for the renewal of soft furnishings, this surprises me as the facility is open the public and, hopefully will get a lot of use.

A budget for soft furnishings for 2020/21 was added because a transition fund of £10,000 was received from Cornwall Council to buy any small furnishing needed for 2019/20.

6. Is there a disaster recovery plan in place, or is the Town Council going to draw up its own?

A copy of the STC Business Continuity Plan 2020/21 is available to view on the STC website. Please note that the latest update is currently awaiting approval at a meeting to be confirmed.

Summary of request: When will first part of cemetery be full (burials) & how will allotments in 2nd/3rd sections be moved/replaced?

Response: The following information was provided:

1. Who owns the walls around St Stephens church yard extension and hence who is allowed to cut the flowers or vegetation that grows in the wall gap?

Response:

The boundary around Churchtown Cemetery is owned and maintained by the Town Council. As part of the ongoing maintenance programme growth is cut back as necessary.

2. When is it estimated that the first part if the extension will be full of burials and hence when and how will the allotments in the 2nd and 3rd sections be moved/replaced?

Response:

The estimated number of full body burial plots available in phase one of the cemetery is 650. At 10th September 2021 there are 70 plots in use with the first burial having taken place in September 2015.

The forecast when the cemetery was planned was that the allotment sites would be in place for approximately 26 years following the commencement of burials in the cemetery.

I am unable to provide any information on future provision of allotments as this would be the decision of a future council as part of their budgeting and planning process. Currently the council is required to provide a five year forecast of expenditure which is updated annually when the precept is set.
