- A38
- Air Quality, with specific reference to Tideford and Landrake.
- Water Transport

Given the priority given to the issue, the CNP agreed to create the Cornwall Gateway Climate Change Network, which has met twice and has also had a separate meeting with Cornwall Council's Nature Recovery team. This network comprises representatives from all Town and Parish Councils in the CNP, in addition to representatives from active groups such as Cornwall Climate Care.

In addition, a focus session was arranged in November to take a deep delve into the topic of health and care. Following the success of this focus session, it is hoped that other single-issue focus sessions will be arranged in the future, capacity allowing,

This year, we welcomed Will Glassup as the new Highways Manager to the CNP and his input, support and guidance has been invaluable. At the last CNP meeting, all welcomed the news that the Community Network highways scheme was to be relaunched, with a budget of £57,000 per annum for 3 years.
