#### 1. Precept 2024/25 Budget Setting

All committees have now met and discussed their budget requirements and reviewed the Town Councils Fee & Charges. A draft report for recommendations are due to be considered at the P&F meeting to be held on 14<sup>th</sup> November.

- Income budgets are based on:-
  - The reviewed Fees & Charges and analysis of current and prior year revenue
- Expenditure budgets are based on:-
  - Matching costs to the budgeted income
  - Analysis of current and prior year expenditures. This exercise has resulted in reducing some budgets for 24/25
  - For gas and electricity costs <u>average annual Kwh usage</u> X <u>current unit</u> <u>cost</u> x <u>15%</u> allowing for inflationary increases
  - Other costs have been increased by the CPI rate of 7.3% set in June
    2023
  - Planned spend recommended by the Property & Maintenance committee
  - EMF budgets recommended by individual committees

The Full Town Council meeting is scheduled for 7<sup>th</sup> December when all recommendations for budgets, fee & charges and setting the precept will be agreed. Cornwall Council have set the precept submission deadline for 29<sup>th</sup> December 2023
